

Colmex Pro – Promotion Terms and Conditions

Trading Commission Credit via TradingView – Equity Accounts

Colmex Pro Ltd (hereinafter “the Company” or “Colmex Pro”) is a financial services company incorporated and registered under the laws of the Republic of Cyprus, with registration no. 260064. Its registered office is located at 117 Makariou III Avenue & Sissifou Street, Quarter of Apostoloi Petrou & Pavlou, 3021 Limassol, Cyprus. The Company is licensed by the Cyprus Securities and Exchange Commission (hereinafter “CySEC”), under license no. 123/10 to provide investment services through its electronic trading platform.

1. The Promotion

Eligible clients with an Equity Trading Account may participate in this Trading Commission Promotion through **TradingView for Equity Accounts** (hereinafter “the Promotion”), subject to the Terms and Conditions outlined below.

2. Terms of Participation

- i. **Eligibility:** The Promotion is available to new and existing Colmex Pro clients who have an equity trading account and trade through TradingView. This offer is currently available only to clients based in Israel, Germany, France, Netherlands, Spain, Austria, Poland, Belgium and Sweden.
- ii. **Promotion Period:** This Promotion begins on 13th November 2024 (“**Start Date**”) and is valid until the 1st January 2027 (“**End Date**”), unless terminated earlier by the Company.
- iii. **Trading Commission Credit:** Eligible clients are entitled to a credit for the trading commissions of their first 10 (ten) successful trades via TradingView, applicable to the minimum order commission amount as specified on Colmex Pro’s [Contract Specifications for Equities](#).
- iv. **Credit Process:** Following the execution of the first eligible trade, a one-time commission credit of up to \$30 (or currency equivalent) will be issued to the client’s trading account on the following calendar day. The credited amount is intended to offset the trading commissions of up to 10 (ten) trades as per the terms of this Promotion, including the first trade placed and is available for withdrawal at any time.
- v. **Timeframe:** Clients have until the End Date to complete the 10 (ten) eligible trades. There is no requirement to complete all trades within a specified timeframe.
- vi. **Account Registration:** Opening a Colmex Pro trading account is subject to the Company’s registration process and internal procedures, which may include passing the Company’s appropriateness test, being within the Company’s positive target market, and approval by the Company.

- i. **Third-Party Platform:** TradingView is a third-party trading interface through which clients may access and place equity orders in their Colmex Pro trading account. While Colmex Pro enables connectivity to TradingView, the platform is operated independently and is not owned or controlled by Colmex Pro.
- ii. **Platform Limitations and Responsibility:** Clients acknowledge and agree that Colmex Pro shall not be held liable for any unavailability, malfunction, delay, disruption, or error occurring on the TradingView platform, including but not limited to:
 - Failure or delay in placing or executing orders,
 - Incorrect display of prices or charts,
 - Interface connectivity disruptions, or
 - Loss of data or trade history due to TradingView platform issues.
- iii. **Execution Responsibility:** Only trades that are successfully routed to and accepted by Colmex Pro's order execution system shall be considered valid for the purpose of this Promotion. In the event of an error or failure originating from TradingView's system that prevents the successful routing or execution of a trade, Colmex Pro bears no responsibility for such failed orders.
- iv. **Client Responsibility:** Clients are responsible for ensuring that they have a stable internet connection, and access to Colmex Pro's broker integration via TradingView. Any operational issues should first be addressed with TradingView directly.
- v. **Limitation of Liability:** To the fullest extent permitted by law, Colmex Pro disclaims all liability for any direct or indirect losses, damages, costs, or expenses incurred by the Client as a result of issues arising from the use of the TradingView platform.
